 - (c) If, on verification of the qualification certificates/DOB/Reservation Category and other documents from the concerned issuing authority are proved fake/forged, the claim of the appointee(s) for appointment as Class-IV (MTS) shall be deemed to have cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/her.
