- 3. If, on verification of the qualification certificates/ DOB/ Reservation Category and other documents from the concerned issuing authority are proved fake/ forged the claim of the appointee(s) for appointment as (Class-IV) shall be deemed to have cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/her.
- 4. The salary of the appointees shall not be drawn and disbursed to them unless satisfactory reports in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate and Final Character & Antecedents Report are received from the concerned Authorities/Agency.
