2. Two passport size recent colour photographs.
3. One original photo ID Proof i.e Aadhar card/ Voter card/ Pan card/ Passport etc.
4. D.O.B certificate.
5. Valid Category Certificate, if any, applicable.
6. Domicile Certificate.
7. Experience certificate (as per the college advertisement notification).
8. Other documents (in original) as per prescribed qualification mentioned in the Advertisement notification.
9. Candidate should bring original documents along with the undertaking/ Affidavit already prescribed in the Advertisement Notification no. VB/WC/Advertisement/66; Dated:- 21-01-2023.
10. If on verification, qualification certificates from the concerned issuing authority are proved fake/ forged or the candidate is possessing lower/higher qualification than the prescribed qualification, the claim of the appointee for appointment as Class III & Class IV shall be deemed to have cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/her.
