**Subject:** Termination of services for violation of eligibility condition and submission of false affidavit.

### ORDER

Whereas, Vishwa Bharti Women's College Rainawari Srinagar, issued a recruitment notice for appointment to the post of MTS vide order mentioned at (a) above, prescribing the educational qualification as "Minimum Matric and Maximum 10+2", and further containing a specific condition that "candidates found guilty of impersonation or submitting fraud/fabricated/tampered documents(s) of making any incorrect or false statement, suppressing material information, shall render them liable for criminal prosecution, if at later stage the information submitted by the applicant is found/fake/incorrect, his selection shall be cancelled ab-initio."

And whereas, the following 07 individuals were selected and Sl. 01 to 06 appointed to the post of MTS and they joined their duties as mentioned against each:-

And whereas, at the time of submission of application and joining, the said candidates furnished judicial affidavits declaring that they do not possess any qualification higher than the prescribed qualification of 10+2.

And whereas, during verification of documents and credentials conducted by Vishwa Bharti Women's College Rainawari Srinagar, it has been found and established that the above individuals are in possession of higher educational qualification, namely Graduation which is beyond the qualification prescribed in the recruitment

notice; and the declaration made by the said individual through the judicial affidavit stating that he/she is not over-qualified is false and incorrect.

And whereas, furnishing false information and suppression of material facts relating to eligibility at the time of recruitment amounts to misrepresentation and violation of the terms and conditions of the recruitment notice as well as the appointment order.

And whereas, the clauses 7 & 8 of the appointment order clearly provides that "the appointment of the above appointees shall be cancelled ab-initio if it is found that they possess higher qualifications than the prescribed one at any stage and he/she shall also be liable for criminal prosecution under law (Clause 7) and If any certificate was found false or any other additional/higher qualification certificate that violates the Advertisement Notice VB/WC/Advertisement/66 dated 21 Jan 2023, the appointment of the candidate shall be taken to have been cancelled ab-initio (Clause 8)."

Therefore, after due verification of the records, documents and educational credentials submitted by above individuals, this Office is satisfied that these individuals do not fulfill the prescribed eligibility condition relating to educational qualification; and have knowingly submitted a false judicial affidavit and concealed material facts to secure appointment.

In view of the above facts, it is hereby ordered that the services of the above individuals selected / appointed as MTS in Vishwa Bharti Women's College Rainawari Srinagar, are terminated forthwith ab-initio, in accordance with clauses 7 & 8 of the appointment order.

The appointments of above individuals are treated as having been obtained by misrepresentation and submission of false information, and consequently the same is rendered void in terms of the recruitment conditions.

The Principal Vishwa Bharti Women's College Rainawari shall:-

- take necessary action to give effect to this order immediately.
- ensure that the documents, false judicial affidavits and false declarations submitted by the above individuals shall be securely placed on record for such further action as may be considered appropriate under the applicable rules and law.

Any payment, benefits or claims, if found to be inadmissible as a consequence of this termination, shall be dealt with as per applicable rules and instructions.

This order is issued without prejudice to any other action that may be initiated against the individual for submission of false information and false affidavit before a judicial authority.
